

NOTICE OF ADOPTION

To the taxpayers of Montgomery County, Indiana.

You are hereby notified that on February 26, 2024, the Board of County Commissioners of Montgomery County, Indiana, pursuant to notice heretofore given, and under and by virtue of Indiana Code §8-16-3 and §6-1.1-41, duly adopted a plan whereby a Cumulative Bridge Fund was re-established to provide for the construction, repair, maintenance and inspection of bridges in Montgomery County.

The fund will be provided for by a property tax of Seven and five-tenths cents (\$0.075) on each one hundred dollars (\$100.00) of taxable real and personal property within the taxing unit (Montgomery County) beginning in 2024 payable in 2025 and thereafter, continuing until reduced or rescinded.

Twenty-Five (25) or more taxpayers in the taxing unit who will be affected by the tax rate and corresponding levy may file a petition with the Montgomery County Auditor not later than 12 noon, 30 days after the publication of this Notice setting forth their objections to the proposed cumulative fund. Upon the filing of the petition, the County Auditor shall immediately certify the same to the Department of Local Government Finance, at which point the Department will fix a date for and conduct a public hearing on the proposed cumulative fund before issuing its approval, disapproval, or modification thereof.

2024 GRAVEL ROAD DUST CONTROL 50/50 TERMS

Montgomery County will do 50/50 Gravel Road Dust Control program for 2024. Dust Control is an oil application that is sprayed in front of residences on gravel roads. The 50/50 program means that Montgomery County will pay for half of the Dust Control application up to 600 feet. Lengths for application are measured in the center of the road. Orders will require a minimum 300 feet. Orders can exceed 600 feet. However, the resident will pay for all additional application after 600 feet. Applications greater than 600 feet must be in increments of 100 feet at a cost of \$335 per 100 feet. (Example: Resident orders 800 feet of application. Montgomery County will pay 50% of 600 feet. Resident will pay 50% of 600 feet and 100% for 200 feet.)

- 1. The county is **not** offering Calcium Chloride, therefore if the resident would like Calcium Chloride they will need to contact the application company directly. It is not part of the 50/50 program.
- 2. The County Highway will send invoices to the resident. Payment MUST be made to the Montgomery County Treasurer's Office either by mail or in person with cash or check. No credit/debit cards will be accepted.
- 3. Sign up will be from February 20th through April 5th. Payment deadline is April 5, 2024. If no payment has been submitted, the county will not spray dust control. Anticipated time to start spraying is May 6, 2024.
- 4. We cannot spray in front of the resident's neighbor without the neighbor's permission.
- 5. We cannot spray on roads we do not maintain.
- 6. All dust control is subject to repair anytime at the discretion of the highway.
