NOTICE OF ORDINANCE ADOPTION

On 11 March 2024, the Crawfordsville Common Council passed an ordinance that Mayor Todd D. Barton approved to take effect on or after publication of this notice. Full text of the ordinance is available upon request of the Clerk-Treasurer of the City of Crawfordsville at 300 E. Pike Street, Crawfordsville, Indiana 47933. An abstract of the ordinance follows:

ABSTRACT - ORDINANCE 8-2024 - AN ORDINANCE REPEALING AND REPLACING CITY CODE CHAPTER 53: DRAINAGE CONTROL REGULATIONS.

HWC Engineering has assisted the City with compiling mandated changes to the City's current MS4 Stormwater Program. The recommended updates develop two distinct documents: (1) Stormwater Ordinance and (2) Stormwater Technical Design Manual. Prior to these changes, the City has utilized a single ordinance for all legal and technical directives. The intent of the proposed changes is to:

- · Bring the City into compliance with USEPA NPDES MS4 program changes as regulated through IDEM December 18, 2021, MS4 General Permit (MS4GP) update (formerly known as "Rule 13").
- · Bring the City into compliance with USEPA NPDES construction and post-construction pollutant control program changes as regulated through IDEM December 18, 2021, Construction Stormwater General Permit (CSGP) update (formerly known as "Rule 5").
- · Allow the City greater flexibility in their continued technical regulation and oversight of new development and redevelopment projects.

The purpose and timing of these changes are simply that the new General Permits require such updates prior to the City's next MS4 audit by IDEM and then annually as long as the MS4 program exists. (Section 4.5(i) of MS4GP).

The ordinance changes remove the technical information from the body of the ordinance to a technical manual. This allows the legal basis for the stormwater program to remain intact under the ordinance itself.

The creation of a separate technical Stormwater Manual takes the place of the ordinance based technical section. This allows the City to easily perform their mandated annual review and technical updates as stormwater standards, engineering, and materials manufacturing processes change. With the Stormwater Manual, the regulation and oversight of issues such as pipe materials, manhole installation techniques, and/or acceptable erosion control materials can be handled through direct Board of Public Works and Safety action each year instead of required council and/or mayoral ordinance change processes.

This ordinance will be in full force and effect immediately upon passage and after any necessary publication. All ordinances or part of ordinances that conflict with this ordinance are repealed.

Violations of the ordinance are punishable by civil fines and penalties under the City Code § 53.21 through and including § 53.29; and § 53.73 through and including § 53.75, in addition to general penalty provisions of the City
