#### NOTICE TO TAXPAYERS OF HEARING ON PROPOSED **CUMULATIVE CAPITAL DEVELOPMENT FUND**

Notice is hereby given to the taxpayers of Civil Town of New Ross of Montgomery County, Indiana, that the Town Council will consider at 105 State Street, New Ross, Indiana at 5:30pm on Thursday, May 9, 2024, the reestablishment of the Cumulative Capital Development Fund under the provisions of Indiana Code 36-9-15.5 for the purposes as follows:

For all uses set out in I.C. 36-9-15.5-2

The tax will be levied on all taxable real and personal property within the taxing district and will not exceed \$0.05 per \$100 of assessed valuation. The proposed fund will be levied beginning with taxes due and payable in the year 2025.

Taxpayers appearing at such hearing shall have the right to be heard thereon. The proposed tax rate for the Cumulative Capital Development Fund is subject to certification by the Department of Local Government Finance. Within 30 days after the date of the adoption of the cumulative fund by the Town Council, the Town of New Ross will publish a Notice of Adoption.

Upon publication of the Notice of Adoption, 25 or more taxpavers in the taxing district may file a petition with the County Auditor not later than noon 30 days after the publication of the Notice of Adoption setting forth their objections to the proposed fund.
